# Chapter 2 Literature Review

#### 2.1INTRODUCTION

Base Isolation is one of the popular passive control techniques (Kelly 1997). The parameters of various isolators are tabulated in Table 2.1.

#### 2.3.1 Elastomeric Bearings

Base isolation is considered to be an aseismic design approach in which the building is protected from the hazards of earthquake forces by a mechanism which reduces the transmission of horizontal acceleration into the structure (Jangid and Datta, 1995).

#### 2.3.1.2 New Zealand System (NZ)




Figure 2.4: New Zealand bearing system (a) Section and element (b) Analytical model (c) Force-deformation behavior

The system behaves essentially as hysteretic damper device. (Lin et. al. 1989a, 1989b). The section and elements of NZ system are shown in Figure 2.4(a), the analytical model is shown in Figure 2.4(b), and the force deformation behavior is shown in Figure 2.4(c).
